One party paid their share and the other one did not (the other party told the ex spouse that her attorney told her she didn't have to pay the tax). A Tax Lien resulted being filed against both parties. The Client didn't find out about it until he tried to buy his new wife a home. Naturally this did not make his new wife very happy as this was her dream home.

Needless to say no one was very happy as the realtors, mortgage broker and the client nor his new wife.

Fortunately we were able to get involved, negotiate with and provide documents to the IRS which allowed the release of Lien so that the new house could be purchased and closed. Net result "Happy Wife, Happy Life". Not to mention the agents and brokers were all able to get paid as well.

Another recent case a Client was attempting to refinance his home to pay for some damages from a storm. When the mortgage company went to close they found a tax lien from an Installment Agreement. By negotiating with the IRS we were able to obtain a Subordination Agreement which allowed the Client to close successfully


